At James Elliman Academy, our primary aim is the safety and well-being of our staff and pupils. We recognise that a school closure will impact differently on all of us and we acknowledge that children and families will face a variety of situations and challenges. With this in mind we take all steps possible to keep school open but have robust contingency plans should school ever need to close.

We would ask all parents and carers to take the time to familiarise themselves with the information below so that our whole community can support our pupils and ensure minimal disruption to their learning if we should be forced to close for any reason.

The government has introduced a tiered system of restrictions to help pupils access face-to-face education for as long as possible in the event of local outbreaks.

In the exceptional circumstances where some level of restriction to education or childcare is required in a local area, local and national partners will carefully consider which of the tiers is the most appropriate one to implement. Under the Coronavirus Act 2020, ultimately the decision to order the closure of school and childcare settings is one for central government.

Decisions will need to be made on a case-by-case basis in the light of local circumstances, including information about the incidence and transmission of coronavirus. Attendance may therefore need to be restricted in different ways to those outlined below if there is specific health evidence that doing so is a necessary measure to help control that specific outbreak or transmission risk.

As measures are relaxed following local restrictions, these tiers can be implemented in reverse. This will ensure minimising time spent in the highest tiers, so schools are able to extend their opening, in a phased manner if appropriate, at the earliest point that it is safe to do so.

As part of their contingency planning, schools will consider how they would operate at each tier in the event that these restrictions become necessary in their local area. The tiers below will only apply if the school is in an area of local restriction/lockdowns. Local and national authorities will decide which tier to implement. Bear in mind that they'll make decisions on a case-by-case basis, and may need to restrict pupil school attendance in different ways.

Parents/Carers will be informed of any closure, including its projected duration, through the School App and the school website. We will also show clear and regularly updated information about closure and its duration. It is the responsibility of parents/carers to check the school app and website daily for updates, during a closure.

Staff will also receive regular email communication to keep them updated and to discuss what tasks can be carried out online/remotely. The school will continue to follow advice from the government and any other agencies throughout any closures.

Provision for distanced working

While school is closed, staff will still be expected to be available for work and to be able to work remotely as much as possible.

Obviously, work that can be carried out remotely will vary for different staff and, for some, much of their work is immediate and pupil facing. However, there is an expectation for teachers to be able to provide work at home as well as answer and send emails and so on.

Working patterns will not be as usual, but school closure should not be seen as holiday time, and there is a responsibility for all teaching staff to maintain quality learning for pupils as much as is possible bearing in mind the constraints we will have.

Provision for distanced learning for pupils

The main access for distanced learning will be the Google Classroom followed by the school website. While most children will have access to online learning, some may not. Some may also not have functioning printers, so it is probably better to avoid massive use of worksheets. Staff will ensure that children have login details in order to access Google Classroom and any other online learning tools provided. If children do not have online access, then text books and work books will be provided.

		Remote Learning
		 Our aim is to keep our core purpose of teaching and learning continuing as effectively as possible. During a school closure each pupil will be provided with learning to do at home and we will have high expectations of all pupils to complete the work set. A programme of learning will be delivered which is of equivalent length to the core teaching pupils would receive in school. Activities and tasks will be shared through Google Classroom. Assignments will be set so that children have work each day in a number of different subjects and pupil engagement with these assignments will be monitored consistently by all teaching staff. A planned and sequenced curriculum will be taught so that knowledge and skills are built incrementally, with clarity about what's intended to be taught and practiced in each subject. We will provide frequent explanations of new content through curriculum, using questions and other suitable tasks, and set a clear expectation on how regularly teachers will check work and provide feedback. Teachers will adjust the pace or difficulty of what's being taught in response to questions or assessments, including, where necessary, revising material or simplifying explanations to
		ensure pupils' understanding. However, JEA do recognise that health and wellbeing are paramount and we appreciate that the level of work that might be undertaken by a child will reflect the situation and circumstances at
		home. If any child is unable to access a computer, tablet or phone, please let us know in order for resources and activities to be arranged and collected.
		 In the event of a national, local lockdown or a bubble within the school, JEA will continue to provide high quality education to our pupils.
		 We will do this remotely using Google Classroom for remote learning as we did previously following the March lockdown.
		• To ensure that our pupils are comfortable with this style of learning, we will introduce some elements into our present class based practice.
		 We will use a curriculum sequence that allows access to high-quality online and offline resources including teaching videos and audio that are linked to the school's curriculum

		 Teachers to contact parents and carers if there are concerns regarding the misuse of Google Classroom.
		 Teachers to monitor pupil engagement and contacting parents and carers if their child is not actively engaging with online learning.
		Children
		 Be assured that wellbeing is at the forefront of our thoughts and the need for children to take regular breaks, get fresh air, exercise and maintain a reasonable balance between online engagement and offline activities.
		 Children will be expected to adhere to set deadlines for returning work whether daily or weekly.
		 Only send messages and queries that are in relation to tasks set by the teacher or in response to questions the teacher may ask them directly.
		 Only access the material shared by their teacher and ask for parental permission to use technology for anything beyond that.
		 Read daily, either independently or with an adult.
		 Consider using the school closure time to learn a new skill, follow their own interests to discover more about the world around us or just be creative.
		Special Needs
		• For children with special educational needs (SEN) we realise this will have an impact on how Education Health and Care Plans are delivered. Extra attention will be given to meeting the individual needs of children and young people with SEN and their families in the

		 Support their child's learning to the best of their ability.
		 Encourage their child to access and engage with Google Classroom.

		 Check their child's completed work each day and encourage the progress that is being made.

		Different Scenarios
		 Infection affects a member of our school community and a case is confirmed.
		 In this scenario, the school would have to follow direct guidance and risk assessment from Public Health England. It is possible that some or all of the school could be closed. A partial closure could affect school meal provision (and would, no doubt, be complicated as regards siblings).
		 In the event of a confirmed case in the school community: "a risk assessment will be undertaken by the educational establishment with advice from the local Health Protection Team. In most cases, closure of the childcare or education setting will be unnecessary but this will be a local decision based on various factors such as establishment size and pupil mixing."
		 High levels of staff illness/absence make it impossible to staff all classes or children
		 In the event of high levels of staff absence, there may be some combination of classes and lessons may not be as formal as usual. Qualified teachers would have an overview of provision, but supervision of pupils could be delegated to suitably experienced support staff on occasions. We would have to make dynamic risk assessments to ensure the health and safety of the school community. In this scenario, it could be that the school would have to partially or completely close.
